Where necessary to make the referenced FAR/DFARS clauses applicable to this order, the following terms of the clause shall be modified: the term "Contractor" shall mean "Seller", the term "Contract" shall mean this order, the term "Contracting Officer" or "Administrative Contracting Officer" shall mean "Buyer," and the term "subcontract" and "subcontractor" shall mean" sub-subcontract "and "sub-subcontractor." Seller will provide whatever reasonable assistance Buyer may require to maintain compliance between the order and any higher tier Government contract under which the order is issued.
